Dear CEG4 students

This email serves as an update that **the FYP presentations will now be conducted in physical/f2f mode** instead of virtually. The default format for FYP presentations has been changed to in-person, as NUS regards physical interaction between students and instructional staff as a crucial hallmark of our instructional quality. In addition, we view the development of soft skills (such as project presentations) as critical skills that need to be cultivated with appropriate practice.

As such, as and when you submit your CA report next week, please make the necessary arrangements to meet and report your progress to your Supervisor and the Main Evaluator during Reading Week. Where possible, the venue may be your supervisor's or examiner's office.

If a suitable venue or timing cannot be arranged despite reasonable effort, a virtual assessment may be allowed on an exceptional basis only. For such cases, it remains that **the student is responsible for hosting and sharing the meeting link with both the Supervisor and Main Evaluator.**

The academic staff will be informed of this, and we seek your cooperation in making the necessary arrangements.

Your FYP CA report is due in a month's time, on 5 Nov (Wed). There isn't a stipulated format for the CA report per se. If you are unsure, do check with your supervisor directly.

1. You can now view your assigned 'Main Evaluator' by logging on to Project Administration System (mySoC <https://mysoc.nus.edu.sg/~projadm/>), and lookup via 'FYP Proposals (**Presentation Sem**)', click on '**2025/2026 Sem 2**'.

2. Please note the important dates for Continual Assessment (CA),
- CA report submission by 5pm, 5 Nov 2025
- CA presentation between 17 – 21 Nov 2025

AND refer to the [Guidelines for CA Presentation](#):

- i. It could be an informal presentation held in the staff office (supervisor or main evaluator), or in discussion/meeting rooms. If the latter is necessary, for CDE venues, please drop by Technical Services @ E1-04-01, while for SoC venues, the respective CS supervisors could help to book. Alternatively, if student wants to conduct CA presentation virtually via Zoom or Teams, it is the student's responsibility to host and share the (video conferencing) link with his/her respective Supervisor(s) and Main Evaluator.
- ii. Based on the report submitted by students, the supervisors and main evaluators can have informal discussion about the student's understanding of the project, progress, what s/he would be doing in the next semester and expected outcome at the end of the project.
- iii. Students may use their laptop to show a few slides.
- iv. Students are allowed to do separate presentations, provided both supervisor and main evaluator are agreeable with the arrangement.

As noted earlier, please submit your CA report directly to your Supervisor and Main Evaluator on time. You are also required to make the necessary arrangements to meet and report your progress to both the Supervisor and the Main Evaluator during the reading week.
