Dear Students,

Reminder that the deadline to secure your VIA placement is **Friday, 17 Apr 2026**. You must do **one** of the following by the deadline.

1. Accept an employer's offer via TalentConnect (TC); or
2. Submit your Self-initiated application via the Enhancement Programme (EP) portal. Do note that the application does not need to be approved by the deadline.

Do note that all students must complete the Canvas Enrolment Survey. Failure to do so may result in issues or a delay in registering your VIA placement in the EP portal.

- If you have accepted an offer via TalentConnect, please be reminded that you do not need to complete the Experiential Learning Form/Record in TalentConnect.

To check if your internship has been successfully registered under the VIA,

- Login to the EP portal.
- Click on 'View Enhancement Programme' -> 'View Programme Status'.
- Details of your internship placement will be shown if it has been successfully registered under the VIA.

If you require an extension to the deadline, please submit your request **with reasons** via email to cde.iacareer.ug@nus.edu.sg. Each request will be reviewed on a case by case basis.

- As mentioned in the Pre-Internship Briefing video, the opportunities for the VIA are significantly less than the IA, so do broaden your search by applying to different Position Types in TalentConnect or directly to prospective employers. If you are looking for additional opportunities to apply to, please check with your Dept Administrators.
- Do note that if you are unable to secure an internship by the deadline, you may have to defer your internship to a later term/semester which may cause a delay in your graduation. Year 2 students may consider doing the IA instead.

We advise that you re-watch Pre-Internship Briefing video Part 2 if you are unsure of any of the processes.
